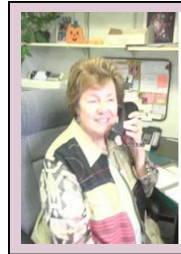

## TRAINING FOR CUSTOMERS USING THE SALCE INSTRUMENT

Several Regional Health Authority (RHA) staff members have contacted ADE Incorporated regarding the possibility of scheduling training on the implementation and interpretation of the SALCE instrument.

ADE Incorporated remains in contact with Crystal Nieviodomy of the Ministry of Health in Regina. Crystal has informed us that due to the re-write of the program during the months of October and

November in 2008, training for all interested RHA personnel will take place in the Spring of 2009. The exact date and location has not yet been determined. The Spring meeting will provide training for new users of the program, as well as refresher training for current users of the SALCE instrument.

ADE Incorporated also offers remote training for all of our customers. The remote training is accomplished through the use of software and a conference call.

The virtual networking software is a small program downloaded to the customer's computer. The customer logs onto a virtual network, which allows ADE staff to perform the actual training over the established network. A conference call allows for two-way communication between the parties.
